Reply Comments of the State Associations Representing Public School Superintendents

INTRODUCTION

The undersigned organizations, representing state superintendent associations across the nation, respectfully submit these Reply Comments urging the Federal Communication Commission (the "FCC") to establish its proposed school and library cybersecurity pilot program. The pilot, once launched, will help address a critical need for initial cybersecurity assistance for our nation's schools and libraries, and will generate invaluable data to better inform future and on-going federal efforts on education cybersecurity policy decisions.

Our associations represent school superintendents and system administrators across 46 states. Our members are committed to integrating technology into all aspects of their districts, including teaching, learning and operations. Through the schools and libraries program ("E-Rate"), as administered by the FCC, schools have been able to transform access to broadband connectivity for students and teachers. With an increased online presence, however, comes increased cybersecurity risk. The risks associated with cybersecurity breaches or attacks can be swift, severe, and far reaching, and school system leaders are constantly working to protect their networks and the invaluable and confidential health, employment, educational and other data they store.

We strongly support the FCC's proposed school and library cybersecurity pilot program. We urge the FCC to move forward with its pilot and focus on an application and implementation process that:

- Generates data the FCC and other federal entities can use to evaluate and better inform future and enduring federal cybersecurity policy improvements, both within and outside of the E-Rate program;
- Is efficient and targeted in its data collection, working to create a dataset that can be readily available for decision-making on next steps for federal cybersecurity support;

- Preserves the proposed three-year timeline while allowing an expedited timeline for participants whose cyber plan can be carried out more quickly (eligible participants should receive their funding in one lump sum and be able to spend down over an 18 to 36-month timeframe);
- Awards the full proposed \$200 million to applicants while acknowledging the initial investment would be but a first step in addressing a pressing reality that will be exponentially more expensive; and
- Allows program beneficiaries to work across school district boundaries.

We align more generally with the comments as filed jointly by our national organization (AASA, The School Superintendents Association) and other national organizations including the school business officials, rural educators, educational service agencies, independent schools, Catholic schools, teachers unions, educators, principals, counselors, and more.

Thank you for opportunity to weigh-in on the particulars of the Commission's cybersecurity pilot proposal and we look forward to working with the FCC as this matter proceeds.
